Notes:

1. The product certification used most closely resembles a product certification scheme type as described in ISO/IEC 17067 (2013), *Conformity assessment — Fundamentals of product certification and guidelines for product certification schemes*.
 - a. **Type 1b:** This scheme type involves the certification of a whole batch of products, following selection and determination as specified in the scheme. The proportion to be tested, which can include testing of all the units in the batch (100% testing), would be based, for example, on the homogeneity of the items in the batch and the application of a sampling plan, where appropriate. If the outcome of the determination, review and decision is positive, all items in the batch may be described as certified and may have a mark of conformity affixed, if that is included in the scheme.
