The International Accreditation Service (IAS) has prepared this update to keep you informed about some of the news and events going on with the Metal Building Assemblers Inspection Accreditation (AC478).



## AC478 Congratulatory Letters to Building Departments

Building departments can make a huge impact on the timeline and cost of a construction project. That's why it is so important that building departments are confident in the competence of the construction company. To this end, IAS will be sending a letter to building departments in jurisdictions where there are companies accredited to AC478. The letters will highlight the accredited company and summarize the benefits of the accreditation for the building department, building owners and community. The same letter will be sent to the International Code Council's (ICC) governmental representatives that are working with building departments in the region. The majority of the building departments in the U.S. are members of the ICC and adopt the building codes published and maintained by the ICC. IAS is a subsidiary the ICC and a member of the code council family of solutions.

## AC478 at the Nation's Annual Conference for Building Officials

## Specification or Accreditation – What comes first?

For ages, the question has been “Which came first? The Chicken or the Egg.” This same question is being asked by companies thinking about getting accredited. “Should I become accredited first, or should I wait for customers to start including specification language that requires accreditation?”

While one company is still trying to answer this question, others are moving ahead with accreditation. They understand accreditation will set the bar for companies assembling metal buildings. When a potential customer asks “Why should I choose your company over the next company, you can give a solid answer with details about what it means to be an IAS Accredited Metal Building Assembler. IAS is an independent, internationally recognized accreditation body that is a leader in the construction industry and a subsidiary of the International Code Council, the organization that develops the building codes. The accreditation process verifies that an assembler has the qualified staff, equipment, processes and training to do the job right. ## Why should your company get accredited to IAS AC478?

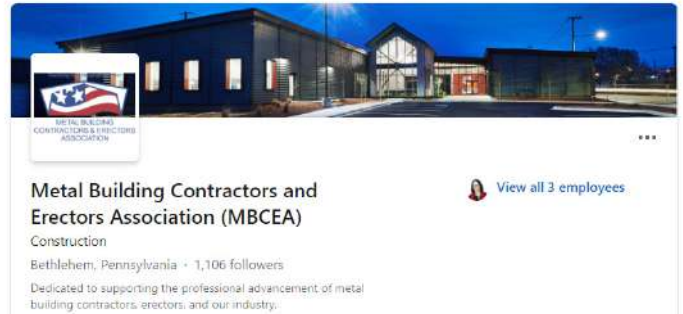

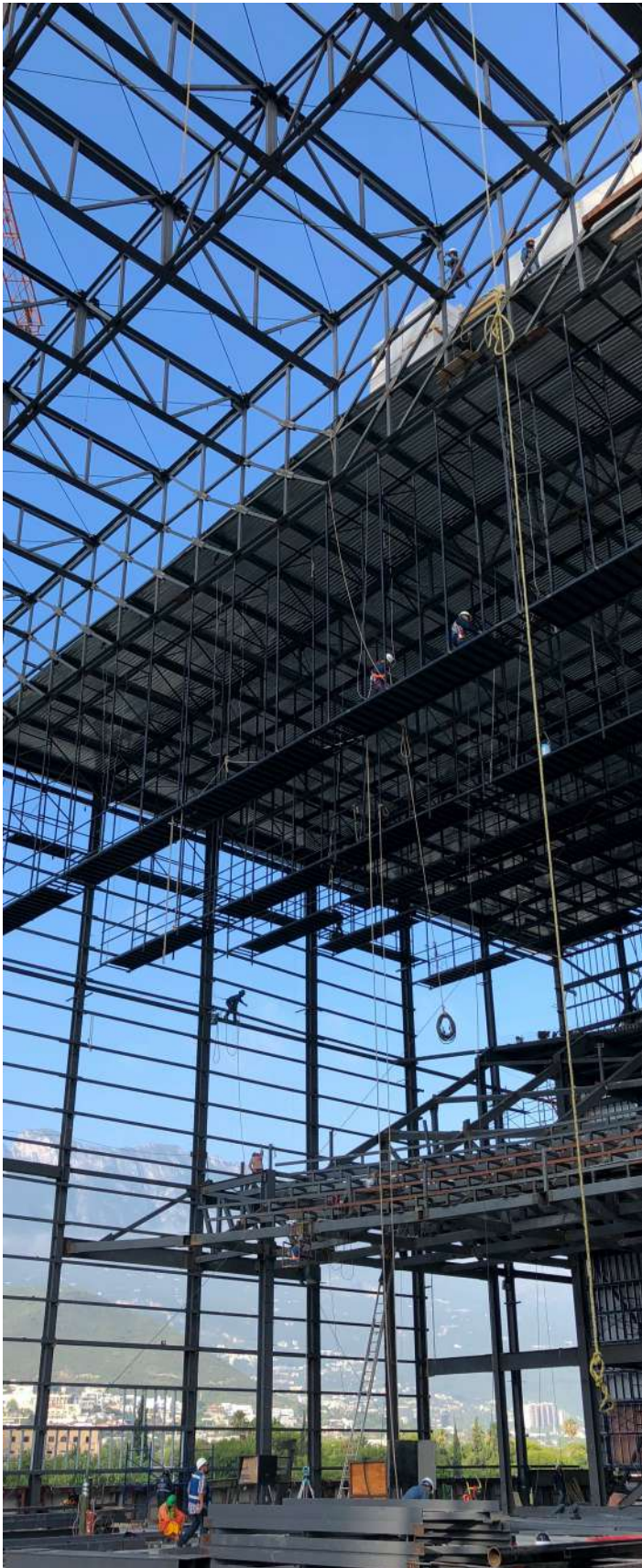
